

Ratha Saphthami: Day for worshipping Lord Surya

On Ratha Saphthami Day,observed today, Lord Surya is worshipped early in the morning while fresh sun rays start emerging. Scientifically, it has been proven that exposure to fresh sunrays rejuvenate energy, and purify our mind and body. That’s why many do suryanamaskaras (Twelve postures of prostrating to Surya) early morning when sunrays are fresh. The scriptures proclaim that “ratha” is symbolic of our mind. The mind is considered as a chariot.

How? Immeasurable thoughts use to arise, flow, awaken in our mind. These very thoughts are like different horses, which pull the minds in various directions. To enable the mind to control and progress toward the divine power, we need to pull the cariot through application of right set of horses to journey in right direction. Spiritual insight and the deeper meaning of Ratha Saptami can be understood through this explanation. .

Ratha Saphthami is the celebration to mark the beginning of spring. This comes on the seventh day after amavasya of Thai. Sun on this day moves from the southeast to the northeast. People worship sun on this day. He who takes bath early in the morning with arka leaf is purified by mother Ganges. Lord Surya is called as “Arogya and Aishwarya Datha” (provider of health and wealth) and source of life. That is why He is placed in the centre of nine planets. Scientists found out that sun is the center of

all nine planets and all of them orbit around the sun. Our sages found out this truth thousands of years ago and mentioned at several places in the Hindu scriptures. In fact, the characteristics of the sun and all the nine planets have been clearly described in the Vedas. One can identify these characteristics in the “navagraha manthra”, and are similar to what the NASA scientists described in their research findings. This is a great testimony to state that many aspects of Hindu faith are scientifically important. In Ramayan, there is one significant teaching : Sage Agasthya advised Lord Shri Ram Prabhu to worship Lord Surya to win the war against Ravan. Sage Agasthya gives Lord Rama Aditya Hridayam Sthothram teaching, before Ram-Ravan war began.

It is said that we should pull the ratha, which is our “mind”, to follow the brahma marga. Our Supreme Paramathma’s wish is this only. Lord Narayana is worshipped as Surya. In this form, the sun as Narayana is “pasya” -worshipped and “pasaana dvara” meaning the outer orbit of Sun is the entry point to Narayana who is at Centre.We worship Lord Suryanarayana for better health and well-being.

In many villages, Arka plants are growing in plenty on street-corners, dilapidated building complexes, etc. which might not have been noticed by many. Seven arka leaves (erukkam or Calotropis Gigantea) play a significant role while taking bath today. Married

women are advised to take holy bath by placing seven Arka leaves on their body along with a pinch of turmeric & raw rice. on top of the leaf. One leaf is kept on the head, two on the shoulders, two on the knees and two on the foot while having a bath. The word Arka is also a synonym for Surya or Sun. The shape of the Ekka leaves is said to represent the shoulders and chariot of Sun God. Its symbolic to note that these seven Ekka leaves being placed on the seven chakras of the body. The “Nadis” are the channels through which the energies of the subtle body are said to flow. They connect at special point of intensity called “Chakras”. It is believed the “Ekka Leaves” has the power to remove any toxicants in the ‘Nadis’ and provide necessary energy to body to absorb the light rays from the Sun God.

The day is very auspicious too to offer tarpana to our ancestors. Radhasaphthami is symbolic of the change of season to spring and the start of the harvesting season. For most Indian farmers, it is an auspicious beginning of the New harvest Year. This is the day that Surya was born to sage Kashyapa and his wife Adithi. The Sun rises early in the morning. Likewise, we should wake up early in the morning before sunrise, bathe and pray to the Lord. Women put Kolam (rangoli) with a representation of Sun God with seven horses in a chariot in front of their dwellings.

Similarly, around 6 in 10 of IT professionals at enterprises report that their company is actively implementing generative AI and another 34% are exploring it. 74% of IT professionals at companies deploying or exploring AI indicate that their company has accelerated their investments in or rollout of AI in the past 24 months in areas like R&D (67%), reskilling/ workforce development(55%) and building proprietary AI solutions (53%).
