Cloudnine saves twin sisters born prematurely

Chennai, Mar 29: After suffering through multiple failed pregnancy attempts, Ashwini, and Arun (names altered to maintain confidentiality) are filled with hope as they welcome what they consider a miracle. Their twin daughters, Sunaina and Ridhi (names changed) arrived prematurely at just 24 weeks on November 26th, 2023.

Following a lengthy stay of approximately 105 days (or around 4 months) in the neonatal intensive care unit at Cloudnine Hospital, OMR, Chennai, the

twins have finally been discharged.

Twin daughters were delivered to Ashwini, aged 36, who was diagnosed with an incompetent cervix during a routine hospital checkup. Ashwini had a medical history involving chronic hypertension, fever, and amniotic fluid leakage.

During the 15th week of her pregnancy, she underwent cervical cerclage, a procedure in which the cervix is temporarily stitched and closed. However, at 24 weeks, Ashwini’s cervix prematurely opened, weakened, and shortened, while she was carrying

twin sisters in her womb and was experiencing persistent high blood pressure and fever.

Dr. Dhilip Kumar S, Senior Consultant – Neonatologist & Pediatrician at Cloudnine Group of Hospitals, Chennai, OMR branch said, “In this case both the twins were born micro preemies at 24 weeks and are indeed miracle babies because and had to undergo two major life threatening surgeries for treating hernia and patent ductus arteriosus

(PDA), a congenital heart defect. Both the twins were very sick, and their survival was doubtful in the early days of birth. They suffered from chronic lung disease and were on ventilator support for two months because lungs were immature to wean off the ventilator support.

Many a times we as doctors felt that these twins will not survive but patience, perseverance is the key for managing these extreme preterm babies.”
