Telangana CM seeks 800 EV buses

Hyderabad May 25: Telangana Chief Minister A Revanth Reddy has requested Union Heavy Industries Minister HD Kumaraswamy to allocate an additional 800 electric buses (EVs) to Hyderabad under the PM-E Drive scheme. The request comes in light of the growing public transport needs of the city.

In a meeting held in Delhi yesterday, CM Revanth Reddy highlighted that 2,000 EV buses had already been sanctioned for Hyderabad. However, considering the increasing urban demand, he urged the Centre to extend the allocation by 800 more buses.

The Chief Minister also proposed adopting a hybrid Gross Cost Contract (GCC) model to ensure that Telangana RTC drivers and mechanics are involved in operating and maintaining these buses, thus preserving local employment.

Revanth Reddy further pointed out the successful retrofitting of a diesel RTC bus in Hyderabad, which is already running on electric power.

He appealed to the Union Minister to support the retrofitting of more existing diesel buses to EVs, promoting both sustainability and cost-efficiency, an official statement said

1. The above audited standalone financial results have been reviewed by the Audit committee on 22nd May 2025 and approved by the Board of Directors of the company at their meeting held on 22nd May 2025.
2. This statement has been prepared in accordance with the companies (Indian Accounting standard) Rules 2015, (IND AS) prescribed under section 133 of the companies Act. 2013.
3. The Company operates in Single segment namely Manufacture of electrical equipment for transmission and distribution of power.
4. The previous quarter's/year's figures have been regrouped/rearranged wherever necessary to make it comparable with Current quarter/year.
5. S&S Power has raised equity capital of Rs.46 crores through a preferential allotment of 61,41,550 shares to the promoters on May 29, 2024(including share issued other than for cash consideration of 30,33,442) with this the Promoters stake has increased to 74.99%. This transaction has also increased the Company's net worth by Rs.91 crores and enabled the company to reduce debt by an amount of Rs.37.75 crore in July 2024. This is in line with approvals received from Shareholders, SEBI and NSE/BSE. These funds were used to acquire the minority stake of 33.14% in Acrastyle Power India Limited thereby converting it into a wholly owned subsidiary. This enabled the company to consolidate 100% of financials of Acrastyle Limited - our UK subsidiary, into the Company.Additionally, S&S acquired 100% stake in Hamilton Research and Technology Limited (HART), a Kolkata based Company in the cutting edge of specialized and proprietary automation technology, with a special focus on the Aluminium sector. HART has been integrated into the Company effective from 1st of June 2024. Therefore previous year's numbers are not fully comparable.
6. Figures for the quarter ended 31st March 2025 and the corresponding quarter ended in the previous year as reported in these standalone financial results are the balancing figures in respect of full financial year and the listing year to date figures upto the end of third quarter of the relevant financial year. Also the figures upto the end of third quarter had only been reviewed and not subject to audit. [As laid down in the regulation 33(3)(e) of SEBI (Published Regulations and Disclosures Regulations, 2015)
7. Update on Employee Stock Option Plan:Grants to CEO & MD:The Board, on September 30, 2024, based on the recommendations of the Compensation Committee, approved 3,70,247 options to Krishnakumar Ramanathan, CEO and MD of SSPSL and 1,23,416 options to Vikas Arora, CEO of HART as per their employment agreement approved by shareholders.Grants to Company secretary:The Board, on September 30, 2024, based on the recommendations of the Compensation Committee, approved the 2,000 options to Prince Thomas, Company Secretary as per his employment agreement approved by shareholders.Grants to other employees:The Board, on September 30, 2024, based on the recommendations of the Compensation Committee, approved grant of 1,26,000 Stock options to eligible employees under the 2024 Plan. The ESOP has been granted by its Ultimate parent company (SSPSL) to its Key managerial Persons (KMPs) and Other eligible employees of its subsidiary companies. The cost of such options has been accounted as recoverable from the respective subsidiary companies. The options would vest only at the end of third year.The Board, on September 30, 2024, based on the recommendations of the Compensation Committee, approved 1,23,416 options to Vikas Arora, CEO of Hamilton Research and Technologies Private Limited as per their employment agreement approved by shareholders.
